The Design Award Jury may make Awards in three echelons of distinction of which the Jury will determine the number, if any, of each Award, with a fourth category for special distinction. These echelons refer to the Design Awards only.

- **Honor Award:** Projects that exhibit the highest distinction.
- **Merit Award:** Projects that exhibit superior quality.
- **Citation Award:** Projects deserving special commendation.
- **Special Recognition:** Specific recognition as determined by the jury for a notable detail, attention to a specific design feature, or other design recognition as determined by the jury.

The act of submittal signifies that the entrant assumes responsibility for the accuracy of information and warrants the permissions have been obtained from all who may have rights to the work, including its representation and photography. Entrants further acknowledge that no royalties or compensation are due. Entrants agree to hold AIA New Mexico, its sponsors, staff, consultants, and members, harmless from all liability and grant AIA New Mexico the non-exclusive right to publish, reproduce, and distribute the entry.

****SUBMISSION REQUIREMENTS****

ELIGIBILITY: DESIGN + PRACTICE AWARDS

- **Entrants:** All entrants must be AIA New Mexico architects in good standing, registered with the New Mexico Board of Examiners for Architects – OR – AIA members in good standing residing outside the state of New Mexico who are licensed with the New Mexico Board of Examiners for Architects and are submitting a project or practice located within New Mexico. Entries from multi-office firms are limited to work designed principally under the authority of a New Mexico office. Only the “firm of record” or, in its absence, the “architect of record” may submit. When the submitting architect is not the sole author, all other participants substantially contributing to the design of the project must be credited in the submittal, regardless of discipline, title, or role.
 - **AIAS and Associate AIA members in good standing are eligible to submit Unbuilt Design Award Entries at a discounted rate.**
- **Projects:** Projects submissions may be located or designed for any location in the World. Built work must be completed and built in the past five years or since January 1, 2021. Un-built entries must have been designed in the last five years or since January 1, 2021.
- **Previous Winners:** Firms and individuals are encouraged to resubmit previously unsuccessful entries. Previous AIA New Mexico Award winners are not eligible for the same award, though previous winners may submit for other awards unless expressly noted.
- **Jury:** The jury reserves the right to consider projects for Awards other than the one for which it was originally submitted.

SUBMITTAL INFORMATION: DESIGN AWARDS

- **Submit to:** All information is to be submitted digitally to a Dropbox folder that will be set up for each individual entrant. An individual link will be sent once payment is received. Please set up a free Dropbox account if you or your firm does not already have one. **Your folder will have a coded name, which will become your Project ID Number.**
- **Anonymous PowerPoint:** Follow the PowerPoint template as set up in Dropbox, available by a link shared with you.
 - Choose a black or white background
 - Maximum of twenty-five (25) slides including slide 1 and 2 as defined below; maximum of 20 MB per submittal per award
 - 1st slide is the Project Data Sheet and must contain the following:
 - Project Name
 - Date of Completion
 - Client’s Name
 - Builder’s Name
 - Building Type
 - Building Area
 - Structural Information
 - Major Materials & Systems
 - Site Features (if appropriate)
 - Project Cost
 - 2nd slide is the Project Summary and must contain the following:
 - Text description describing program requirements and solutions (not to exceed 150 words).
 - For unbuilt projects, please describe how the project was started and what phase the project is in currently (not to exceed 150 words).
 - Summary should maintain anonymity of the firm/architect of record.
 - File must be saved as .ppt or .pptx (no .pdf or alternate format allowed).
 - Site and floor plan drawings must include a north arrow and a graphic scale

****SUBMISSION REQUIREMENTS (cont.)****

- Images should not be larger than 300 dpi resolution
 - For adaptive, restoration, or renovation work, provide at least one image of conditions prior to the work;
 - For the 25-Year Building Award, provide at least one image taken within 3 years of the project's original completion date and at least one image taken within the last 12 months showing the project's current status.
- **Separate High-Resolution Image Files & Photography Release:** In your Dropbox folder, please include a separate set of images (up to 8) that may be used for the presentation of awards. Each entry must include a signed Photography Release form. This form is found on page 31. It will also be in your Dropbox folder as a fillable PDF.
- **Project ID Form:** Each project entry must include a fully completed Project ID form, which contains all the information necessary for a certificate, should the project win an award. Please double check all spelling. Your Project ID number is the name of the Dropbox folder assigned to you. This form is found on page 30. It will also be in your Dropbox folder as a fillable PDF.
- **Intern Compensation Disclaimer:** Each entry must include a signed Intern Compensation Disclaimer. This form is found on page 32. It will also be in your Dropbox folder as a fillable PDF.
- **Presentation Boards for Design Awards:** Each entrant shall provide a 24" x 24" x 3/16" thick rigid board (such as gator board or foam core) that has a black or white background and includes information and/or images regarding the project submitted. The boards will be retained by AIA New Mexico for a year to be displayed at AIA New Mexico's elevAte party, and then exhibited at various locations throughout the state, including UNM SA+P. **You may include the name of the firm/architect and the project on the Presentation Boards.** Please arrange drop-off with nmdirector@aianewmexico.org, and deliver the presentation/design boards to the following:

- **Self-Nominations:** Self-nomination of awards should be limited only to Design, Performance, and Practice Award categories. You may also self-nominate for Leadership Awards; however AIA New Mexico feels the distinction of the Leadership Awards should also include a letter from another AIA member or AIA Chapter supporting the nomination's dedication to the profession and the community.

URBAN & REGIONAL PLANNING AWARD (Design Category)

Criteria: Given for significant achievements in the planning, conception, design, and execution of projects at regional and urban scales, which sensitively reinforce historic or existing urban form, connect the internal and surrounding community, exhibit sustainability at a community scale, and respond to context through form and materials.

Awards: Jury may make Honor, Merit, Citation, or Special Recognition Awards.

Submission: Describe the project as required in slide 1 and slide 2. On subsequent slides, provide images and/or comments that further describe the design process to show client and community involvement and acceptance. Address at least two topics in each of the following categories:

- **Urban/Ecological Form:**
 - Response to, or reinforcement of, extant/historical/cultural development patterns.
 - Strategies for the capture, collection, storage, and distribution of renewable resources.
 - Use of material at an urban scale and the relation of this strategy to Place.
 - Siting and orientation in response to climate, extant settlement patterns, and landscape
- **Walkability/Community Connectivity:**
 - Connectivity to existing context and circulation patterns.
 - Accommodations and promotion of pedestrian, cycling, transit, etc.
 - Accommodations of parking (and if it was able to be reduced)
- **Water/Energy/Carbon Reduction:**
 - Ecological stewardship practices on an urban scale.
 - Building scale stewardship practices for renewables.
 - Data on energy, water, and other renewable practices relevant to code requirements.

25-YEAR AWARD (Design Category)

Criteria: Given to a distinguished work of architecture whose aesthetic statement, craft, and relevance have endured for twenty-five or more years, thus withstanding the test of time.

Awards: Jury may select up to one Award per year.

Eligibility: Open to all types of built projects completed twenty-five or more years ago; one or a group of structures. Project must be in good condition and substantially complete.

Submission: Any AIA member, group of members, or committee may nominate a building for this award. Describe the project as required in slide 1 and slide 2. On subsequent slides, provide images or data that show how the project has contributed to the profession or the community it is serving and why it is deserving of recognition from the perspective of a quarter-century. In addition to the PowerPoint, please provide the following:

Nomination Letter:

- Summarizing the significance of the project.
- Verification of the project's age.
- List of project contributors – including architect, client, contractor, consultants, and others making significant contributions.
- Supplemental information or testimony to document the project's significance.
- Project data, if known.
- Explanation of any known modifications to the original project.
- Limit of two pages.

Criteria: Given for significant achievements in the planning, conception, design, and execution of projects that exhibit values esteemed in New Mexico: sense of place; response to culture and climate; energy consumption and projected climate change; ecological stewardship; materiality; and design quality among others.

Awards: Jury may make Honor, Merit, Citation, or Special Recognition Awards.

Submission: Describe the project as required in slide 1 and slide 2. On subsequent slides, provide images and/or comments that elucidate the project and its value. Address at least two topics in each of the following categories:

- **Architecture:**
 - Overall design concept.
 - Articulation of the formal architectural language.
 - Architectural embodiment of Place.
 - Conditions and characteristics of the site and their influence on orientation and site design.
- **Materiality & Craft:**
 - Innovative use of materials and/or design strategies that amplify the properties of materials or reinforce Place.
 - Use of locally-sourced, low carbon materials and/or how materials used relate to the landscape and Place.
 - Treatment of materials with respect to climate and use that create a narrative of weathering/aging.
 - Explanation of how fabrication, assembly, or construction were formative in the architectural language.
- **Sustainability:**
 - Ecological stewardship practices.
 - Renewable energy strategies.
 - Water conservation strategies.
 - Social responsibility strategies.
 - Addressing future climatic impacts (drought, urban heat island, flooding, etc.).

INTERIOR ARCHITECTURE AWARD (Design Category)

Criteria: Given for significant achievements in the planning, conception, design, and execution of interior projects that exhibit values esteemed in New Mexico: sense of place, design quality, materiality, cultural relevance, and stewardship.

Awards: Jury may make Honor, Merit, Citation, or Special Recognition Awards.

Submission: Describe the project as required in slide 1 and slide 2. On subsequent slides, provide images and/or comments that elucidate the project and its values. Address at least two topics in each of the following categories:

- **Architecture:**
 - Overall design concept.
 - Articulation of the formal architectural language.
 - Architectural embodiment of functional and technical requirements.
 - Response to and embodiment of Place.
 - Natural and artificial lighting concept and implementation.
- **Materiality & Craft:**
 - Innovative use of materials and/or design strategies that amplify the properties of materials.
 - Use of locally-sourced materials or materials that evoke Place.
 - Demonstration of how furniture, fixtures, equipment, and systems support the design concept.
 - Explanation of how fabrication, assembly, or construction were formative in the architectural language.
- **Sustainability:**
 - Ecological stewardship practices.
 - Renewable energy strategies.
 - Water conservation strategies.
 - Social responsibility practices.

COMPONENT ARCHITECTURE AWARD (Design Category)

Criteria: Given for building insertions, site installations, furniture, light fixtures, urban kiosks, shade structures, and other components, either stand-alone or in response to a specific context or place, that demonstrates design excellence in an element of limited size.

Awards: Jury may make Honor, Merit, Citation, or Special Recognition Awards.

Submission: Describe the project as required in slide 1 and slide 2. On subsequent slides, provide images and/or comments that elucidate the project and its values. Address at least two topics in each of the following categories:

- **Design:**
 - Articulation of the formal architectural language.
 - Architectural embodiment of functions and technical requirements.
 - Response to and embodiment of Place.
 - Conditions and characteristics of the site and their influence on orientation and site design.
- **Materiality & Craft:**
 - Innovative use of materials and/or design strategies to enhance material properties.
 - Use of locally-sourced materials and/or how materials used relate to the landscape or Place.
 - Treatment of materials with respect to climate and use that create a narrative of weathering and aging.
 - Description of how fabrication and assembly were formative in the design language.
- **Sustainability:**
 - Ecological stewardship practices.
 - Renewable energy strategies.
 - Water conservation strategies.
 - Social Responsibility Strategies.

UNBUILT DESIGN AWARD (Design Category)

Criteria: Given for important achievements in the execution of commissioned projects that were intended for construction but remain unrealized, including competition entries and urban design. Unbuilt designs created by AIAS or Associate AIA Members are eligible.

Awards: Jury may make Honor, Merit, Citation, or Special Recognition Awards.

Submission: Describe the project as required in slide 1 and slide 2. Include a brief description (it can be on slide 1, slide 2 or any other slide), summation on why the project is un-built and if there are plans and/or a timeline to have it constructed. On subsequent slides, provide images and/or comments that elucidate the project and its values. Address at least two topics in each of the following categories:

- **Design:**
 - Articulation of the formal architectural language.
 - Architectural embodiment of functions and technical requirements.
 - Response to and embodiment of Place.
 - Conditions and characteristics of the site and their influence on orientation and site design.
- **Materiality & Craft:**
 - Innovative use of materials and/or design strategies to enhance material properties.
 - Use of locally-sourced materials and/or how materials used relate to the landscape or Place.
 - Treatment of materials with respect to climate and use that create a narrative of weathering and aging.
 - Description of how fabrication and assembly would have been formative in the design language.
- **Sustainability:**
 - Ecological stewardship practices.
 - Renewable energy strategies.
 - Water conservation strategies.
 - Social Responsibility Strategies.

SUSTAINABLE & RESILIENCY DESIGN AWARD (Performance Category)

Criteria: Given for significant achievements and innovations that advance a post-carbon world, through environmental balance, healthy spaces, and energy, water, material and resource conservation and that exhibit values esteemed in New Mexico: sense of place; response to culture and climate; energy consumption and projected climate change; ecological stewardship; materiality; and design quality among others.

Awards: Jury may make Honor, Merit, Citation, or Special Recognition Awards.

Submission: Describe the project as required in slide 1 and slide 2. On subsequent slides, provide images and/or comments that elucidate the project and its value. Address at least two topics in each of the following categories:

- **Sustainability Features**
 - Innovation and Efficiency: Contributions to environmental balance, energy efficiency, appropriate land use, minimal ecological impact, reuse of existing buildings, resource conservation, and use of non-renewable resources.
 - Transferability of concepts.
 - Integration of systems and strategies into architectural language.
 - Use of architectural/engineering design elements.
 - Social responsibility strategies.
- **Resiliency Features**
 - Adaptability to natural and human-cause hazards, climate change and the degradation of natural resources that challenge the integrity of buildings.
 - Acknowledges flexibility for changing conditions in the physical, economic and social environment.
 - Mitigates unknown risks and vulnerabilities.
 - Explanation of how materiality, fabrication, assembly, or construction were formative in creating durable building envelopes.
 - Balances first costs and long-term value over the intended service life.
- **Architecture 2030 Building Energy Use**
 - Explanation of reduced building energy demand.
 - Expanded explanation of passive design strategies – solar heating, cooling, shading, ventilation, daylighting, etc. Use text and diagrams to describe actual architectural integration and function of sustainable design strategies.
 - Building energy use data:
 - Reduced energy demand.
 - Passive design strategies.
 - Performance simulation – Submit the results of a building energy model (Sefaira, Insight 360, or other) in BTU/ft²/year with a comparison to a baseline for the building. Simulation shall use the ZeroTool to find the base line (zerotool.org).
 - EUI data – Submit the results of actual building energy usage for buildings occupied over 12 months.

SUSTAINABLE & RESILIENCE DESIGN AWARD (cont.)
